

Data Subject Request form

This Data Subject Request Form ("this Form") should be used to submit a request to access or correct information about individuals ("Personal Data") in accordance with the Bank for International Settlements ("BIS") Personal Data Protection Policy. Any natural person ("Data Subject") of which the BIS processes Personal Data has the following rights:

The BIS also processes Data Subject requests that concern international associations hosted by the BIS (FSB, IADI, IAIS) on behalf of and in collaboration with the association concerned ("Hosted Associations").

Any natural person ("Data Subject") of which the BIS/Hosted Associations processes Personal Data has the following rights:

- The right to obtain confirmation that the BIS/Hosted Associations processes your Personal Data;
- The right to receive certain information about the processing of your Personal Data;
- The right to obtain a copy of your Personal Data the BIS/Hosted Associations processes (as applicable).

The request process comprises of three phases:

Phase 1: Submit request form to the PDP Manager

- Provide your details and (if applicable) details of your legal representative
- State your request

Phase 2: The PDP Manager may ask for additional information to help process your request

- The PDP Manager may ask you or your representative for supporting documents to verify your identity, correspondence address, or authority of the legal representative (if any).
- The PDP Manager may request additional information from you in accordance with the BIS Data Protection Policy and/or ask for clarification in cases where the request seems unclear or unspecific.

Please promptly provide additional information requested by the BIS in order to enable the processing of your request.

Phase 3: Processing of request and response

- The PDP Manager will respond in writing and in English to the Data Subject or its legal representative (if any) in accordance with the BIS Personal Data Protection Policy.
- The PDP Manager may refuse requests in accordance with the BIS Personal Data Protection Policy stating the reasons.
